#### 8. Discussion and Approval of CAMPO Executive Director to Begin Negotiation of Audit Services Contract

The Vice Chair recognized Ms. Theresa Hernandez, CAMPO Finance Manager who presented a request for CAMPO Executive Director to begin negotiation of an audit services contract.

A solicitation was sent to more than 75 firms and posted to the CAMPO website. A total of 5 (five) proposals were received and scored by an evaluation team. Montemayor Britton Bender PC was identified as the top ranked firm.
