4. Report from the Technical Advisory Committee Chair......Ms. Amy Miller, TAC Vice Chair

Ms. Amy Miller provided an overview of the discussions from the December 17, 2018 meeting. Ms. Miller reported that the TAC approved recommendations for adoption of the Draft Public Participation Plan (PPP) and approval of FY 2018 Federal Transit Administration (FTA) Section 5310 projects.

9. Update on FY 2017 Audit Finding Results

The Chair recognized a representative from the audit firm Montemayor Britton Bender PC who updated the Board on CAMPO's FY 2017 audit finding results.

Mr. Archie Montemayor reported that Montemayor Britton Bender PC completed a September 2017 audit of CAMPO. A clean opinion was issued on the financial statements. Mr. Montemayor noted that reflects the CAMPO change of fiscal agents from the City of Austin to Williamson County. A review of the draft audit report was conducted by Williamson County staff prior to issuance of the final report. The final audit report was issued in October 2018.

Mr. Montemayor later reported that a memo was drafted to address the Policy Board members' inquiries on the audit raised during the December 2018 TPB meeting.

10. Update on TxDOT Performance Measure Targets (PM2/PM3)

The Chair recognized Mr. Tim Lomax of the Texas Transportation Institute (TTI) who provided an update on TxDOT Performance Measure Targets (PM2/PM3). Mr. Lomax reported that the federal government sets performance measures which are mandated to be utilized by Metropolitan Planning Organizations (MPOs) and the State. Performance measures are required to be reported to the Federal Highway Administration (FHWA). Mr. Lomax informed the Board that the intent was to incentivize MPOs to use them in developing their own performance measures. TTI was asked to develop a process that will enable MPOs across the state to provide input into performance measures, at TxDOT's request.

Mr. Lomax later highlighted and discussed target setting basics and provided recommendations on the performance measure targets.

a. Amendment to Bergstrom Spur

Mr. Ashby Johnson reported that an administrative amendment was processed for the Bergstrom Spur Study, at the request of the City of Austin. The Bergstrom Spur Study was initially allocated in the TIP for 2021. At the request of the City of Austin, the Bergstrom Spur Study was moved to 2019.

b. Capital-Alamo Connection Study Joint MPO Board Meeting

Mr. Roger Beall of the TxDOT Transportation Planning and Programming Division reported that the purpose of the Capital-Alamo Connection Study is to develop strategies to relieve congestion along the Austin and San Antonio corridor. A Joint MPO Board Meeting was held on December 5, 2018 in New Braunfels. Mr. Beall summarized the discussions and presentations from the meeting. Mr. Beall noted that the Executive Summary for the Capital-Alamo Connection Study was made available to the Board in advance of the meeting.
