# 8. Discussion on Transportation Development Credit (TDC) Application for Regional Transportation Demand Management (TDM) Program

The Chair recognized Mr. Ryan Collins who also presented and summarized the TDC application for the Regional TDM Program. Mr. Collins informed the Board that the application requests 124,000 TDCs to be applied to the primary project, Regional TDM Program and required secondary maintenance of effort project is CAMPO's existing General Planning Consultant contract. Mr. Collins noted that this item will be presented for approval at the March Transportation Policy Board meeting.

Mr. Collins identified seven (7) categories used by the federal government to set performance measure targets and summarized the implementation process. Mr. Collins also highlighted the target setting summary and briefly discussed the performance measure targets that are updated annually and every four (4) years. Mr. Collins later informed the Board that the State has adopted performance measure targets with a 2% reduction.
