# 2. Approval of the July 19, 2021 Meeting Summary...... Ms. Laurie Moyer, P.E., Chair

Approval of the July 19, 2021 meeting summary was deferred to the October 18, 2021 meeting.

# 3. Discussion on Federal Transit Administration (FTA) 5310 Project Call

......Mr. Ryan Collins, CAMPO

Mr. Ryan Collins, Short-Range Planning Manager provided a brief overview of the FTA 5310 Program and identified Capital Metro as a designated recipient of FTA 5310 funds. Mr. Collins informed the Committee that staff received 12 applications for approximately \$13 million in requests and following thorough review for eligibility and readiness, staff is finalizing the project scores. Mr. Collins briefly discussed the evaluation process. A brief question and answer concluded the presentation.

# 4. Discussion Refunding Opportunity of Deferred Projects

Mr. Ryan Collins also provided an overview of the refunding opportunity of deferred projects. Mr. Collins informed the Committee that approximately \$15 million in Surface Transportation Block Grant (STBG) funding has become available to refund Category 7 deferred projects as a result of Transportation Policy Board approval of the Capital Express Project.

Mr. Collins highlighted the deferred projects list eligible for STBG funding and informed the Committee that project sponsors included on the list were contacted for confirmation of project status. Mr. Collins noted that project readiness will be prioritized first in the evaluation process.

The Committee was advised that the deadline for applications is October 8, 2021 at 5:00 p.m. The presentation concluded with a brief question and answer with comments.

# 5. Demographics Update and 2020 Census

Mr. Greg Lancaster, Travel Demand Modeling Manager provided an update on demographics and the 2020 Census. Mr. Lancaster informed the Committee that staff received a request at the May Transportation Policy Board meeting for population totals from the 2020 Census to the model. A brief question and answer concluded the presentation.

### 6. Presentation of Planning for Emerging Technologies

Mr. Miguel Arrellano, Deputy District Engineer and Ms. Akila Thamizharasa, Director of Advance Project Development jointly provided a presentation on Planning for Emerging Technologies.

Ms. Thamizharasa discussed the objective for planning for emerging technologies and provided a detailed overview of emerging technologies. Ms. Thamizharasa also highlighted regional initiatives by TxDOT, CTRMA, and the City of Austin in addition to overlapping initiatives.

Mr. Arrellano provided a detailed overview of the regional approach, needs and benefits, and next steps which included the following:

- 1. Commitment of Collaboration
- 2. Setup Subcommittee on framework of agreement
- 3. Regional review panel
- 4. MPO initiated policies, regional emerging technology plan/ Transportation Systems management and operations (TSMO) plan
- 5. Recommendation to manage investments and outcomes
- 6. Per CAMPO member's recommendations, develop tiered criteria to set

A question and answer with comments concluded the presentation.

Mr. Ashby Johnson, CAMPO Executive Director informed the Committee that CAMPO will proceed with forming a subcommittee to the TAC as indicated. Mr. Johnson also discussed a timeline to proceed with policy development.

### 7. Report on Transportation Planning Activities

Mr. Chad McKeown reported that the changes received from the TAC have been incorporated into the map and list of projects for regional corridor improvement study presentation. Mr. McKeown summarized the Transportation Policy Board discussion of the information presented at its September 13, 2021 meeting and informed the Committee that staff received approval to move forward with regional corridor improvement. The report was concluded by a brief discussion of the next steps. A brief question and answer followed.

# 8. Discussion and Take Appropriate Action on CAMPO Assistance with Project Readiness for Regional Corridor Improvement Projects

The Chair recognized Mr. Chad McKeown who informed the Board that this agenda item is a carryover information item discussed twice by the Board and TAC. Mr. McKeown highlighted the proposed regional corridor improvement projects, provided an overview of the project goals, and summarized the feedback received from the TAC.

Commissioner Jeffrey Travillion later joined the meeting.

A timeline for the proposed regional corridor improvement was later highlighted and discussed. The Chair informed the Board that the Transportation Policy Board entered into an agreement years ago with the Central Texas Regional Mobility Authority (CTRMA) to use funding that was available to the Transportation Policy Board for the construction of managed lanes on Mopac. The Chair added that the Mopac managed lanes have since been constructed and were very successful prior to the COVID-19 pandemic.

The Chair reported that a request was made (2) two years ago by the CTRMA to buy out of the agreement at a discounted rate. The Chair informed the Board that a subcommittee was formed to discuss the terms of the agreement and a buyout option. Members of the subcommittee included Transportation Policy Board Chair, Commissioner Cynthia Long and board members Mr. Terry Mitchell, Council Member Ann Kitchen, Commissioner Edward Theriot, and Commissioner Clara Beckett.

The subcommittee also received input from an outside municipal financial analyst employed by CAMPO and concluded that further discussion was required to determine a discount rate acceptable to the Transportation Policy Board and CTRMA for an early buy out option.

The Chair recognized Mr. Ashby Johnson who informed the Board that he was directed by the subcommittee to continue discussions with Mr. James Bass, CTRMA Executive Director to come to a mutual agreement on a discount rate. Mr. Johnson reported that discussions with Mr. Bass are weekly, productive, and ongoing.

# 13. Executive Director's Report on Transportation Planning Activities

# a. Transportation Development Credit Program and Advance Funding Agreements

Mr. Ashby Johnson reported that CAMPO recently received documentation from TxDOT on the Transportation Development Credit (TDC) Program and recognized Mr. Ryan Collins as the presenter of the information, as included in the meeting materials.

Mr. Collins reported that TxDOT issued new guidance requirements for Texas Metropolitan Planning Organizations (MPOs) on how to administer TDC Programs. Mr. Collins provided a timeline of previous updates to CAMPO's TDC policy and confirmed that CAMPO is in compliance of the new guidance requirements for its TDC Program.

# b. TxDOT Highway Emergency Response Operator (HERO) Patrol Service to City of Round Rock 18-Wheeler Accident

Mr. Johnson reported that CAMPO received a letter from an individual commending TxDOT's HERO Program for its response to a recent 18-wheeler accident that occurred in the City of Round Rock. Mr. Johnson provided a brief overview of the HERO Program and noted that the program is funded by CAMPO and quite successful.

The Chair requested that a status update on the expansion of the HERO Program is added to an upcoming meeting agenda.

Mr. Johnson announced that Transportation Policy Board Chair, Commissioner Cynthia Long was recognized as receiving Honorable Mention by the National Association of Metropolitan Planning Organizations (AMPO) for her efforts in supporting the mission of MPOs.

Mr. Johnson also announced that he was contacted by the Transportation Research Board (TRB) of the National Academy of Sciences and asked to serve as Chair of its Consensus Committee for a period of 18 months to look at equity in Transportation. Mr. Johnson reported that the Consensus Committee is a national committee that provides expert guidance to Congress and sometimes to the White House on specific subjects. Mr. Johnson informed the Board that following discussions with the Transportation Policy Board Chair and others, he has accepted chairmanship of the committee.

The Chair congratulated Mr. Johnson on his upcoming chairmanship and commended him on his talents and skillset that extend far beyond the region.

- I. **INTRODUCTION** The Federal Aid Highway Act of 1962 promulgated the requirement that all urban areas of 50,000 or more population develop and maintain a comprehensive, cooperative, and continuing (3-C) transportation planning process. The process would establish a transportation plan and provide the procedure by which it would be maintained and revised on a continuing basis.
  - A. **PURPOSE** The Unified Planning Work Program (UPWP) provides descriptive details for the Capital Area Metropolitan Planning Organization (CAMPO) planning process for FYs 2022- 2023. This activity is required under federal law defining the responsibilities of Metropolitan Planning Organizations (MPO). The UPWP serves as the document for identifying ways to carry out the continuing, cooperative and comprehensive transportation planning process in the six-county Capital Area in Central Texas. An MPO is required to perform all planning tasks set forth in federal laws and regulations, many of which are conducted annually. However, some tasks require more than one year to complete and are carried forward from one UPWP to the next. To effectively identify all work tasks, CAMPO prepares this UPWP with input from federal, state and local jurisdictions and transportation providers in the CAMPO region.

#### FAST Act Planning Factors

FAST Act contains ten broad planning areas that should be considered when developing plans and programs. The work tasks contained in the FYs 2022 - 2023 UPWP have considered the following ten areas, some more directly than others:

- 1. Support the economic vitality of the metropolitan area, especially by enabling global competitiveness, productivity, and efficiency.
- Increase the safety of the transportation system for motorized and nonmotorized users.
- 3. Increase the security of the transportation system for motorized and nonmotorized users.
- 4. Increase accessibility and mobility of people and freight.
- Protect and enhance the environment, promote energy conservation, improve the quality of life, and promote consistency between transportation improvements and State and local planned growth and economic development patterns.
- 6. Enhance the integration and connectivity of the transportation system, across and between modes, for people and freight.
- 7. Promote efficient system management and operation.
- 8. Emphasize the preservation of the existing transportation system.
- 9. Improve the resiliency and reliability of the transportation system and reduce or mitigate storm water impacts of surface transportation; and
- 10. Enhance travel and tourism.

Further, the work tasks consider the federal performance goals in the following seven areas:

- 1. Safety
- 2. Infrastructure Condition
- 3. Congestion Reduction
- 4. System Reliability
- 5. Freight Movement and Economic Vitality
- 6. Environmental Sustainability
- 7. Reduced Project Delivery Delays
- B. DEFINITION OF AREA The CAMPO planning area includes all of Bastrop, Burnet, Caldwell, Hays, Travis and Williamson Counties (Appendix B) and the cities and villages in each of the six counties (a comprehensive list of these jurisdictions can be found at www.campotexas.org). By federal definition, CAMPO's planning area must at least include the urbanized area (as defined by the U.S. Bureau of the Census) and the contiguous area that may reasonably be expected to become urbanized in the next 20 years.

During the 2010 census, a very small portion of Guadalupe County was included as a part of the newly urbanized area of San Marcos. San Marcos intends to remain part of CAMPO. Therefore, an agreement was developed between CAMPO and the Alamo Area MPO (AAMPO) regarding the roles and responsibilities of each MPO concerning this portion of Guadalupe County. CAMPO agrees that staff will meet as needed to review progress of planning efforts to discuss key findings from program activities and to discuss the scope, plans, and implementation of activities. To help ensure continuity of federal and state funds, CAMPO agrees to abide by the methodology and process used to allocate funds to the respective MPOs. CAMPO agrees to abide by the methodology and process currently used to allocate federal transportation planning funds to the respective MPOs. CAMPO agrees to work with the AAMPO to identify the need for corridor projects that cross the CAMPO and AAMPO planning area boundary.

C. **ORGANIZATION** – The <u>Transportation Policy Board</u> (**Appendix A**), develops regional transportation policy, allocates state and federal funding to implement the short- and long-range transportation plans for CAMPO. The Policy Board consists of 21 elected and appointed county, city, Texas Department of Transportation (TxDOT) and Capital Metropolitan Transportation Authority (CMTA) officials.

Other committees, task forces or study groups may be formed from time-to-time throughout the year as necessary.

CAMPO currently operates with various professional staff positions. The professional staff covers the tasks listed in the UPWP. Depending on the budget and/or work tasks to be completed, CAMPO may employ a varying number of consultants, interns, permanent, or temporary personnel.

#### Functional Responsibilities of Planning Agencies

For the transportation planning process to function properly, the agencies involved

must work together cooperatively. The Transportation Policy Board (TPB), the Texas Department of Transportation (TxDOT), Central Texas Regional Mobility Authority (CTRMA), Capital Metro, Capital Area Rural Transportation System (CARTS) and the local governments within the planning area are responsible for carrying out the urban transportation planning process consistent with local agreements. This process includes planning for roadways, bicycling facilities, pedestrian facilities, freight movement, passenger rail, and transit.

The following descriptions of functional responsibilities for each agency are not intended to limit the participation of any agency or local government in the study. Rather, they are brief descriptions of primary responsibilities.

<u>Metropolitan Planning Organization</u> - The MPO, in cooperation with CTRMA, mass transit operators, planning agencies and local governments:

- 1) Is responsible for carrying out and maintaining the urban transportation planning process to include:
  - a. Cooperative decision-making, principally, by elected officials of local governments.
  - b. Unified Planning Work Program (UPWP),
  - c. Transportation Improvement Program (TIP),
  - d. Metropolitan Transportation Plan (MTP), and
  - e. Congestion Management Process (CMP).
- 2) Executes contracts and/or agreements necessary to carry out the work outlined in the UPWP.
- 3) Develops and maintains transportation databases and analytical tools.

MPO staff has the following general responsibilities:

- Provide staff support to the Transportation Policy Board (TPB), the Technical Advisory Committee (TAC), and committees of the Policy Board and TAC.
- 2) Review and report on items on the agenda(s) for the TPB, TAC, and appropriate committees.
- 3) Coordinate and perform the planning and data collection activities contained in the UPWP.
- 4) Prepare and submit an annual budget outlined in the UPWP for approval.
- 5) Receive and review all bills from consultants that the MPO has contracted with to perform work outlined in the UPWP.
- 6) Submit requests for reimbursement to the appropriate federal and/or state agencies for work performed according to the UPWP.
- 7) Prepare and submit grant applications for federal/other assistance in transportation planning, and related fields, as appropriate.
- 8) Prepare and submit the annual performance and expenditure report and annual project listing.
- Coordinate the activities for the development and maintenance of the Unified Planning Work Program, the long-range Metropolitan Transportation Plan and the Transportation Improvement Program.
- 10) Refine and maintain a process for engaging the public in the transportation planning process; and

- 11) Perform any other administrative duties as required by the Transportation Policy Board; and,
- 12) Ensure compliance with Title VI Civil Rights, Environmental Justice and other federal requirements related to CAMPO's operations, activities and programs.

#### Texas Department of Transportation

The Texas Department of Transportation (TxDOT), within the realm of transportation planning, has the following varied responsibilities for the CAMPO planning area:

- Highway planning.
- Participating and lead agency in appropriate transportation studies and environmental documents.
- Review of all FTA Section 5307, 5310 and Section 5311 capital grant applications that may involve state funding: and

In addition, TxDOT maintains certain transportation database files and forecasting models, and coordinates its planning efforts with the MPO through the UPWP.

#### Capital Area Rural Transportation System (CARTS)

CARTS is the rural public transportation provider for this region and has primary responsibility for rural transit planning and operations in the study area.

#### Capital Metropolitan Transportation Authority (Capital Metro)

Capital Metro is a provider of public transportation in the region. Capital Metro has primary responsibility for conducting various short and long-range transit studies, maintaining all transit data, and is responsible for transit planning and operation in the urban portion of the study area.

#### **Counties**

Williamson County acts as our fiscal agent and provides support for human resources, benefits, accounting, and information technology.

The Counties of Bastrop, Burnet, Caldwell, Hays, Travis and Williamson have the primary responsibility for the planning of all roads outside incorporated areas that are not on the State system. The counties also perform analyses on the state system in cooperation with the TxDOT – Austin District. The County coordinates its planning with TxDOT and incorporated areas in extraterritorial jurisdictional areas.

#### <u>Cities</u>

All jurisdiction cities in our planning area have the responsibility for the planning of all off-system roads within their incorporated area, and some have negotiated agreements with TxDOT to plan for roads on the state system as well in cooperation with TxDOT.

#### Public/Public and Public/Private Partnerships

The CAMPO region continues partnerships with local governments and transportation agencies and has actively pursued various partnerships with entities established to advance planning for and improve the area's transportation infrastructure.

- D. PRIVATE SECTOR INVOLVEMENT Consultants have been and will continue to be used on an as-needed basis in CAMPO's transportation programs and planning processes. In the past, CAMPO has used private sector consultants for a variety of services ranging from legal services to corridor studies to improvements to the regional travel demand model. The use of consultants will continue as needed.
- E. PLANNING ISSUES AND EMPHASIS The Federal Highway Administration and Federal Transit Administration have jointly issued Planning Emphasis Areas (PEAs). The PEAs are planning topical areas for MPOs and State DOTs to develop and identify work tasks for FY 2022 and 2023. The Planning Emphasis Areas are:
  - MAP-21 Implementation Transition to Performance Planning and Programming: CAMPO continues to engage in performance-based planning and programming as required by MAP-21 and the FAST Act including the adoption of federal and state performance measures for Safety (PM1), Pavement/Bridge Conditions (PM2), System/Freight Performance (PM3) and Transit Asset Management (TAM). These performance measures are regularly updated, amended, and incorporated into the development of planning products including the Transportation Improvement Program and Regional Transportation Plan. Additionally, project programming and funding efforts undergo a rigorous performance-based evaluation process.
  - Regional Models of Cooperation Ensure a regional approach to transportation planning by promoting cooperation and coordination across transit agency, MPO and state boundaries:

CAMPO will continue to strive to improve the effectiveness of transportation decision making by working with regional partners to think beyond traditional borders and adopt a coordinated approach to transportation planning that supports common goals and capitalizes on opportunities related to project delivery, congestion management, safety, freight, livability, and commerce across boundaries. Improved multi-jurisdictional coordination promises to reduce project delivery time and enhance the efficient use of resources. Enhanced cross-jurisdictional communication will improve collaboration, policy implementation, technology usage, and performance management.

3. Ladders of Opportunity - Access to essential services:

Through the transportation planning process, CAMPO will work with regional partners to identify connectivity gaps in accessing essential services, including employment, health care, schools/education, and recreation. Staff will research analytical methods to identify gaps in the connectivity of the transportation system and identify infrastructure and operational solutions that provide the public, especially the traditionally underserved populations, with adequate access to essential services. Potential tasks include: evaluating the effectiveness of public transportation plans for engaging transportation disadvantaged communities in the transportation decision making process; updating the Section 5310 Coordinated Human Services Public Transportation Plan; assessing the safety and condition of pedestrian and bicycle facilities; and evaluating compliance with the Americans with Disabilities Act, particularly around schools, concentrations of disadvantaged populations, social services, medical and transit facilities.

CAMPO will work cooperatively with TxDOT, CARTS and Capital Metropolitan Transportation Authority (CMTA) to define performance measures that emphasize these seven federal goals: 1. Safety

- 2. Infrastructure Condition
- Congestion Reduction
   System Reliability
- 5. Freight Movement and Economic Vitality
- 6. Environmental Sustainability
- 7. Reduced Project Delivery Delays

#### SUBTASKS

#### Subtask 1.1 MPO Staff Work for Task 1.0

The primary activities which will take place under MPO Staff Work include the following:

**1.1.1 Program Administration**: This activity includes development and implementation of those policies and guidelines necessary to carry out and maintain the transportation planning process; maintenance of the FY 2022 & 2023 Unified Planning Work Program, development of the Annual Performance and Expenditure Report (APER) and Annual Project Listing (APL), development of the FY 2024 & 2025 Unified Planning Work Program, sponsoring and conducting

meetings including providing support to policy and advisory bodies; coordinating and working with other agencies and organizations involved in planning, programming and implementation of transportation projects.

**1.1.2** <u>Public Participation</u>: This activity supports the implementation of the MPO's Public Participation Plan to include the conduct of community outreach and public meetings/hearings as needed with emphasis on Environmental Justice populations and the development/review processes of the Transportation Improvement Program, Metropolitan Transportation Plan and other planning products; develop and use of questionnaires, online surveys, newsletters and other participation techniques; and provide bilingual materials and translations as appropriate.

**1.1.3** <u>Title VI Civil Rights/Environmental Justice (EJ)</u>: This activity supports monitoring and evaluating Title VI/EJ guidance and requirements, developing and implementing documents and procedures to ensure CAMPO's plans, programs and activities comply with Title VI/EJ guidance and requirements, collecting and analyzing data related to minority, low income, limited English proficiency and other populations vulnerable to potential disproportional adverse impacts from the planned transportation system and transportation projects, identifying possible strategies to minimize, avoid or mitigate potential disproportional adverse impacts on the EJ populations, maintaining, coordinating efforts to develop the Regional Toll Network Analysis that evaluates the impacts of the regional toll network on the EJ and non-EJ populations (see Task 2.0), implementing the CAMPO Limited English Proficiency Plan and updating that plan as needed.

**1.1.4** <u>**Travel and Training:**</u> This activity supports staff development in the technical activities associated with the transportation planning process through travel to and attendance at appropriate conferences, courses, seminars, and workshops (AMPO, APA, ESRI, TransCad, TxDOT, TRB, UT at Austin, CNU, etc.). CAMPO will seek prior approval from TxDOT for Out-of-State travel.

**1.1.5** Equipment/Office Space & Computer Hardware/Software: This activity is for the upgrade/addition of, equipment/office space and computer hardware or software to ensure program efficiency. ### PURPOSE AND EXECUTIVE SUMMARY

Approximately \$15,000,000 in Surface Transportation Block Grant (STBG) funding has become available to refund deferred projects. The Capital Area Metropolitan Planning Organization (CAMPO) is currently requesting project applications from sponsors for any deferred projects that fall on or under this funding availability threshold for consideration.

Sponsors of deferred projects that are not ready to be refunded, are over the current funding availability threshold but desire to be considered for future refunding opportunities, or no longer intend to seek refunding are being asked directly to provide written notification by the deadline to ensure accurate management of the deferral list and refunding process going forward. The complete deferral list from the June 8, 2020 action is provided in the attachments and will be updated for the November Transportation Policy Board meeting based on sponsor responses. Additional process information is provided in the STBG Refunding Process Information attachment.

Sponsors are being asked to complete an online application with the requested information or provide a written response regarding their projects by 5:00 P.M. Central Standard Time on October 8, 2021.

## FINANCIAL IMPACT

This process will potentially allocate up \$15,000,000 in STBG funding to deferred projects.

## BACKGROUND AND DISCUSSION

On April 30, 2020, the Texas Transportation Commission (TTC) dedicated funding to the central portion of the IH-35 Capital Express Project. The TTC funding reduced the unfunded portion of the project to \$934 million. To address the funding gap, the TTC requested the reprioritization of more than \$633 million in currently funded projects from CAMPO and the TxDOT-Austin District.

On June 8, 2020, the Transportation Policy Board (TPB) approved a selection of STBG funded projects to be deferred in support of the IH-35 Capital Express project. Upon approval, the TPB endorsed the prioritization of these deferred projects for refunding as additional sources become available. The formal prioritization process was approved in January 2021.

## Background

On April 30th, 2020, the Texas Transportation Commission (TTC) updated the Unified Transportation Plan (UTP) to facilitate the development and implementation of the central portion of the IH-35 Capital Express Project, which has an estimated \$4.9 billion construction cost. The TTC action reduced the unfunded portion of the project from \$4.34 billion to \$934 million. To address the \$934 million funding gap, the Texas Department of Transportation (TxDOT) requested the reprioritization of more than \$633 million in currently funded projects in the Capital Area Metropolitan Planning Organization's (CAMPO) six-county region and the TxDOT-Austin District.

To accommodate the \$633 million reprioritization, CAMPO staff worked closely with the TxDOT-Austin District to develop a process to identify currently funded projects to be deferred until additional funding becomes available from state and federal sources. CAMPO was responsible for developing the process and approval of projects with Category 7 – Surface Transportation Block Grant (STBG) funding. The TxDOT-Austin District was responsible for the process and approval of projects with Category 2 – Metropolitan and Urban Area Corridor Projects, Category 4 – Statewide Connectivity Corridor Projects, and Category 12 – Strategic Priority funding.

## Process Summary

On June 8, 2020, the Transportation Policy Board approved the selection of Category 7 projects to be deferred in support of the IH-35 Capital Express project. Upon approval, the TPB also formally endorsed the prioritization of these deferred projects for refunding. To facilitate this directive, a process was developed and approved to evaluate and select projects from the deferral list to be refunded as additional funding becomes available.

The process focuses on project readiness and prioritizes projects that are most ready to use the available federal funding; only utilizing project scores and ranking to differentiate between similarly ready projects. The process also considers potential changes that may have occurred both with the sponsor and individual projects as a result of the deferral, project development, and other factors. The process is summarized below:



Readiness will assess projects based on the project development process and the resulting schedule for utilizing the federal funding as it is critical to ensure that projects are able to utilize the funding in a timely manner and that the projects have completed all of the necessary steps in order for the federal funding to be obligated in a timely manner. Because Surface Transportation Block Grant (STBG) funding is allocated to the region each federal fiscal year, projects will be grouped on anticipated fiscal year of obligation, which is determined by the readiness evaluation, environmental clearance and letting schedule certification to be determined by TxDOT.

For the readiness evaluation, sponsors will provide a summary of the project progress regarding the applicable development phases. Sponsors must provide a narrative summary and include supporting materials for status verification. For detailed information on the project development process and verifying materials please refer to resource section of this document.

## **Current Refunding Opportunity**

Approximately \$15,000,000 in Surface Transportation Block Grant (STBG) funding has become available to refund deferred projects. The Capital Area Metropolitan Planning Organization (CAMPO) is currently requesting project applications from sponsors for any deferred projects that fall on or under this funding availability threshold for consideration.

Sponsors of deferred projects that are not ready to be refunded as this time or are over the current funding availability threshold but desire to be considered for future refunding opportunities must provide written email notification to Ryan Collins at <u>ryan.collins@campotexas.org</u> by the deadline below. This is to ensure accurate management of the deferral list and refunding process.

Sponsors of projects that have moved forward with other sources of funding, have been cancelled, are no longer eligible due to major scope changes, or for any other reason no longer desire, need or are eligible to be considered for refunding may disregard the application and process. Projects for which CAMPO does not receive an application or written notification of desire for future consideration will be removed from the deferral list and further refunding consideration.

Sponsors must a complete an online application with the requested information or provide written notification for future consideration by 5:00 P.M. Central Standard Time on October 8, 2021.

## **Application Instructions**

Deferred project sponsors may submit an <u>online application</u> with all required supporting materials for refunding consideration. Information provided in the application must be supported with attached documentation as noted in the application instructions. When utilizing the online form please note the following information:

- Online applications can be saved and resumed at any time however applications that have been inactive for longer than 30 days are automatically deleted. You will receive a new link every time you save the application that is good for 30 days.
- Do not attach supporting materials until the session you intend to submit as attachment files are not saved when you use the save and resume function.
- Supporting materials will be required to verify new information provided in the application. Please be sure to attach source materials and additional information as indicated in the application instructions.
- Most application fields are required to ensure complete applications. You may move between sections, but you will not be able to submit until all required fields are complete.
- Attachment fields that are not required are due to certain sections not being relevant to all projects or if there are no changes to the project. However, supporting documentation is required for certain sections and any aspects of the project that have changed from the original application.

## **Application Information**

The online form is comprised of sections that reflect the project development activities that lead to project implementation and allow sponsors to provide updated information on the status of the deferred project. The sections are comprised of questions regarding any changes to the project phases from the original application, a narrative section for brief update responses, and a section for attaching supporting documentation relevant to the project phase and response.

## **Project Management Information**

Sponsors must provide information on the project manager and responsible person in charge (RPIC). The RPIC must have a current Local Government Project Procedures (LGPP) certification.

## **General Project Information**

Sponsors must provide the general project information. Any changes to this project information can be detailed in the relevant sections of the application.

## **Project Scope**

Sponsors must provide current information on the project scope. If there are no changes in the project scope from the original application, please indicate so in the narrative field. For projects with significant changes to the project scope please explain these changes and provide additional documentation in the attachment field.

## **Project Schedule**

Sponsors must provide detailed information on the updated project schedule including the current phasing schedule and anticipated fiscal year of project funding utilization for the approved phases and provide documentation in the attachment field.

## **Cost Estimate and Budget**

Sponsors must provide an updated professionally developed project cost estimate and budget. This updated estimate must reflect the current estimated cost of implementation and include updated information such as engineering refinements, inflation adjustments, updated labor and material costs etc. For projects with significant estimate changes to the previously awarded estimate please explain these changes in the narrative section and any potentially impacts as a result. Please provide documentation in the attachment field.

## **Financial Commitment**

Sponsors must provide current information on the local government financial commitment to the project. If there have been any changes to the financial commitment such as removal from the budget or any other changes to the project sponsors commitment or ability to provide for the upfront costs or local match, please detail this in the narrative section and provide supporting documentation in the attachment field.

## **Coordination and Agreements**

## PURPOSE AND EXECUTIVE SUMMARY

Sponsors and projects awarded funding by the Capital Area Metropolitan Planning Organization (CAMPO) Transportation Policy Board (TPB) are required to demonstrate continual progress through the project development process. To monitor progress, sponsors are required to submit a quarterly progress report for each individual project which is reconciled with the state and federal reporting systems. This report provides the TPB a comprehensive review of sponsor progress and individual project development to inform potential funding decisions and ensure that federal transportation funding is being invested as effectively as possible.

### FINANCIAL IMPACT

Surface Transportation Block Grant (STBG) funds do not lapse, however funding allocated to projects that are not moving forward in a timely manner ultimately harms the region by tying up funds that could otherwise be utilized on other viable projects. Transportation Alternatives Set-Aside (TASA) funding lapses four years after it is apportioned to the region. Sponsors awarded TASA funding must utilize the funding on their projects within this timeframe or the funds lapse and are no longer available to the sponsor or the region.

## BACKGROUND AND DISCUSSION

CAMPO is responsible for allocating certain federal and state funds for transportation projects in the sixcounty capital region. To administer these funding programs and ensure an effective and equitable distribution to project sponsors, CAMPO developed a project evaluation and selection process with an emphasis on several key factors including the ability of sponsors to implement projects effectively. As part of the process, sponsors and projects awarded funding by CAMPO's TPB are required to demonstrate continual progress through the project development process. Projects that do not demonstrate progress may be defunded at the discretion of the TPB.



The progress reporting system is an <u>online form</u> that is based on the project development process outlined by the Texas Department of Transportation's Local Government Project Procedures.


This report is a compilation of the quarterly progress reports to-date, sponsor coordination meetings, and reconciliation with the state and federal reporting systems. This report is intended to provide the TPB with a complete understanding of overall sponsor progress and individual project development to inform potential funding decisions and ensure that the region is moving forward.



## **Overview**

Over the last 10 years, the Capital Area Metropolitan Planning Organization (CAMPO) has directly allocated over \$472 million dollars in federal funding to 122 projects and 30 sponsors through the Surface Transportation Block Grant (STBG) and the Transportation Alternatives Set-Aside (TASA) programs. Of those projects, nearly 46 projects totaling \$98 million dollars have been completed, 40 projects are currently active totaling \$371 million dollars.

#### PURPOSE AND EXECUTIVE SUMMARY

The Capital Area Metropolitan Planning Organization (CAMPO) manages the competitive project selection process for awarding federal FTA funding through the Section 5310 Program. This program awards funding for projects that enhance mobility for seniors and person with disabilities by providing funds to serve the special needs of transit-dependent populations beyond traditional public transportation services and Americans with Disabilities Act (ADA) complementary paratransit services.

CAMPO received 12 applications totaling \$13,069,497 in requests for the 2021 Project Call. Staff and the designated recipient are currently reviewing proposals for eligibility and readiness to ensure sponsors and their program or services are adequately prepared to receive federal funding. Projects that are determined to be eligible and ready will then be evaluated using the scoring criteria and the information provided in the application and supporting documentation. Results of the readiness evaluations and scores will be provided in the recommendation report to be provided in October.

#### FINANCIAL IMPACT

This project call will potentially allocate up to \$2,108,585 in funding to eligible projects with no less than \$1,100,190 to be allocated to traditional capital projects and no more than \$1,008,395 to be allocated for other eligible projects and operating expenses.

#### **BACKGROUND AND DISCUSSION**

The FTA Enhanced Mobility of Seniors and Individuals with Disabilities Section 5310 program is intended to enhance mobility for seniors and person with disabilities by providing funds for programs to serve the special needs of transit-dependent populations beyond traditional public transportation services and ADA complementary paratransit services.

The Capital Metropolitan Transportation Authority (Capital Metro) serves as the designated recipient of FTA Section 5310 Funds in the Austin Urbanized Area and serves as the program administrator. Recipients of the grant funding are selected by CAMPO through a competitive process. Selected applicants enter into a grant agreement with Capital Metro and become subrecipients for these funds. These grant agreements outline federal, state, and local requirements related to project administration and reporting and vary depending on the type of funding, project proposed, agency, and other factors.

The Section 5310 program is a reimbursable grant program, where the selected sub-recipients incur expenses and are reimbursed through the program until the federal award is exhausted. Because of this, sub-recipients must have sufficient funds available to incur program expenses.

# GUIDE FOR APPOINTMENTS TO THE TECHNICAL ADVISORY COMMITTEE

The Technical Advisory Committee (TAC) serves as an advisory group to the Transportation Policy Board (TPB). The TPB relies on the TAC to review technical information provided by the CAMPO staff or other relevant organizations to support the development of the Long-Range Plan, the 10-Year Program of Projects required by House Bill 20, and the Transportation Improvement Program. The TPB expects the TAC to provide recommendations to the TPB on a slate of transportation projects and activities upon completion of their review of all relevant technical information.

In order to ensure that the TAC functions as intended, it is important that each member jurisdiction of the TPB appoint TAC members and alternates that have the knowledge, experience, and responsibility to represent them. A TAC appointee and their alternate should hold a college degree and have substantial experience in civil engineering or transportation planning. Each TAC appointee and their alternate should also be a senior member of the organization and should have the level of responsibility to encumber public funds on behalf of the appointing jurisdiction. Most importantly, the TAC appointee and their alternate should have direct responsibility for the development and implementation of transportation projects.

Please find below a guide that may be used when considering the appointment of a TAC member. The guide gives some indication as to the level of responsibility a TAC appointee and their alternate should hold in their organization. The guide is not an exhaustive list. Ideally, a TAC appointee and their alternate will fall into one of the job titles (or a title closely equivalent) below:

Cities (All Categories – Smaller Cities, Between 50,000 & 500,000, Above 500,000)

- □ City Manager or Assistant City Manager
- Director and/or Assistant Director of Public Works
- Director and/or Assistant Director of Transportation
- Director and/or Assistant Director of Planning

#### **Counties**

- □ County Engineer or Assistant County Engineer
- □ Director of Infrastructure, Public Works or Transportation

#### **Transportation Organizations**

- □ Director or Assistant Director
- □ Organizational Lead for Engineering or Planning
