


## **Annual Listing of Obligated Projects**

The Capital Area Metropolitan Planning Organization (CAMPO), established in 1973, serves as the federally designated Metropolitan Planning Organization (MPO) for the six-county capital region in central Texas. CAMPO coordinates regional transportation planning and funding within Bastrop, Burnet, Caldwell, Hays, Travis, and Williamson counties.

In cooperation with the state transportation department, transit operators, and local governments, CAMPO develops and maintains the Transportation Improvement Program (TIP) and Regional Transportation Plan (RTP). The RTP is the long-range document that outline the goals, strategies, and objectives of the Transportation Policy Board and includes transportation projects planned over the next 20 years. The TIP is the four-year program that consists of federal, state and locally funded transportation projects from the RTP that will be implemented within the next four years. Projects include roadway, transit, transportation, intelligent transportation systems, studies and programs that will improve the region's transportation system.



CAMPO also publishes the annual listing of obligated projects, which provides a summary of federal funding obligated to transportation projects listed in the Transportation Improvement Program over the previous federal fiscal year. These obligations, the legal commitment that the federal government will fund the federal share of a project's eligible cost, occurs when the Federal Highway Administration or Federal Transit Administration execute the project agreement. All listed projects with obligated federal surface transportation funding have been subject to CAMPO's public participation plan through the Transportation Improvement Program development process and approved by the Transportation Policy Board. 
