7. Discussion and Take Appropriate Action to Authorize CAMPO Executive Director to Begin Negotiation of Legal Services Contract

The Chair recognized Mr. Chad McKeown, CAMPO Deputy Executive Director who informed the Board that the current Legal Services contract expires in February 2025. Mr. McKeown discussed the budget and provided a brief overview of the procurement process for the Legal Services contract.

Mr. McKeown identified Tim Tuggey Law as the top ranked firm and requested Transportation Policy Board approval to authorize the CAMPO Executive Director to begin negotiations of a Legal Services contract with the top ranked firm.

8. Discussion on FY 2026-2029 Call for Projects

The Chair recognized Mr. Ryan Collins who informed the Board that the FY 2026-2029 Call for Projects is a process that will allocate funding for the Transportation Alternative Set-Aside (TASA) Program and Carbon Reduction Program (CRP) funding. Mr. Collins also informed the Board that the due date for project submittals is December 20, 2024.

Mr. Collins discussed funding availability and provided a high-level summary of the project selection and evaluation process for the FY 2026-2029 Call for Projects and discussed the project call schedule.

9. Presentation on CAMPO Regional Safety Action Plan

The Chair recognized Mr. Nicholas Samuel, CAMPO Senior Lead Regional Planner who provided brief comments on the development of the CAMPO Regional Safety Action Plan. Mr. Samuel introduced Mr. Brian Chandler, DKS Associates as presenter.

Mr. Chandler informed the Board that CAMPO received \$2.3 million from the U.S. Department of Transportation to conduct a roadway safety action plan through the Safe Streets and Roads for All (SS4A) Grant Program and highlighted the project scope, goals, and objectives. Mr. Chandler also informed the Board that the CAMPO Regional Safety Action Plan is a regional plan with individual chapters for each member county. Mr. Chandler noted that Travis County received its own SS4A Grant and is currently developing its own safety action plan. Mr. Chandler discussed the Safe System approach and five (5) principles for Regional Safety Action Plans, presented the draft vision and goals, and summarized the next steps for the CAMPO Regional Safety Action Plan.

Ms. Doise Miers, CAMPO Community Outreach Manager informed the Board that the public comment period closes on November 18, 2024 and discussed options to offer public comments. Ms. Miers briefly summarized public outreach activities for the five (5) counties included in the CAMPO Regional Safety Action Plan and noted CAMPO's participation in the City of Manor's Night Out event to provide information on the CAMPO Regional Safety Action Plan. Ms. Miers also noted that Travis County staff was also invited to participate in the City of Manor's Night Out event to provide information on the Travis County Safety Action Plan initiative.

10. Executive Director's Report on Transportation Planning Activities

The Chair recognized Mr. Ashby Johnson, CAMPO Executive Director who provided a brief refresher on the processing of administrative amendments to the Transportation Improvement Program (TIP) and noted that the project scope, budget, and project limits cannot change. Mr. Johnson reported that CAMPO processed a series of administrative amendments to existing projects in the TIP and highlighted those administrative amendments.

Mr. Johnson briefly highlighted the groundbreaking for the I-35 Capital Express Central Project and congratulated the Texas Department of Transportation (TxDOT)-Austin District on the major milestone for the region and the state.

The Chair reported that she served as speaker for the groundbreaking for the I-35 Capital Express Central Project and offered congratulatory comments commending the TxDOT-Austin District on its hard work on the project.

Mr. Tucker Ferguson, P.E., TxDOT-Austin District Engineer offered comments of appreciation for the hard work of Ms. Heather Ashley-Nguyen, TxDOT-Austin District Transportation Planning & Development Director on the I-35 Capital Express Project and informed the Board that Ms. Ashley-Nguyen is the recipient of the Gibb Gilchrist Award for her work on the I-35 Capital Express Project, as well.

Mr. Johnson continued in reporting that CAMPO is continuing its initiative with the TxDOT-Austin District to create a regional traffic management center.

Mr. Johnson summarized discussions held with regional partners to develop strategies in moving forward and highlighted a presentation by the City of San Marcos's Director of Public Works, Mr. Sabas Avila, P.E. on an innovative traffic management system currently implemented by the City of San Marcos.

Mr. Johnson congratulated the City of Austin on being the recipient of a discretionary grant award for the Barton Springs Road Bridge Replacement Project and the City of Cedar Park on being the recipient of an ATTAIN grant award.

Mr. Johnson concluded in reporting that following a discussion with Mr. Richard Mendoza, City of Austin Director of Transportation and Public Works on the City of Austin's project grant awards, CAMPO will process a special amendment to include those projects in the Transportation Improvement Program for consideration at the January Transportation Policy Board meeting.
