What is the UPWP?

The Unified Planning Work Program (UPWP) is a federally required document that identifies the planning priorities and activities to be carried out within the CAMPO region. The UPWP is adopted every two years and may be amended.





FY 2026-2027 UPWP Amendment #1

- Add \$176,000 FTA 5307 Funds and \$44,000 Local Funds for the City of San Marcos Transit Route Study
- Add \$458,640 TASA Funds and \$152,880 Local Funds for Hunter Road Trail Connectivity and Development Study
- Add \$416,000 TASA Funds and \$104,000 Local Funds for Eanes Creek Trail Feasibility Study
- Add \$366,000 PL Funds for myProjects





Overview of 2019 PPP updates:


- Changed tiered system to system based on planning document type
 - Prior to update, RTP was only program that had specific outreach requirements
 - Or Changed RTP to require two phases of public commenting and outreach
 - » Added requirements for TIP and CAMPO studies
 - Added requirement for online open houses and commenting
 - » Added notifications to include social media and website
- Added more examples of practices in appendix




Regional Safety Action Plan (RSAP)

Study Purpose

8,945+ Consecutive Days of Fatalities

Since November 7, 2000, Texas has seen at least one traffic death every single day.







Regional Safety Action Plan (RSAP)

Vision and Goals

VISION

The streets and roads in the CAMPO region are safe, accessible, and well-connected for road users of all abilities—pedestrians, cyclists, transit users, and drivers alike.

GOALS

Reduce fatal and serious injury crashes:



50% by 2035



ZERO by 2050

- Report assessed 17 different areas of safety








Regional Crashes

- Down 2.4 percent from 2023
- Statewide crashes down only 0.9 percent.

REGIONAL CRASHES, 2015-2024










Regional Crashes Rates

- Regional crash rate continues to register below the state's rate










Regional Fatalities and Fatality Rates

- Fatalities dropped 4.7 percent from 2023
- 15.8 percent down from 20year high recorded in 2022
- Still 13.7 percent higher than
 10 years ago.








Regional Serious Injuries and Injury Rates

- 5.2 percent drop from 2023
- Still nearly 33.8 percent higher than 2020 lows
